Director Vejraska, with a second from Director Alms, made a motion to adjourn the meeting.

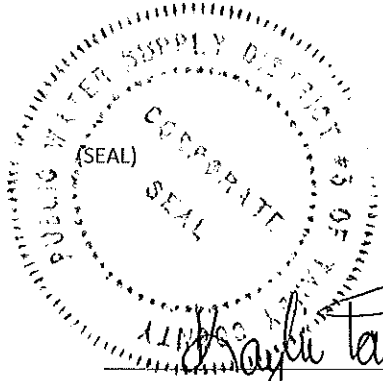
